# **Helping Members Cope with Change**



Change creates, among other things, stress. One thing we are assured of in the coming year is change. However, the exact nature of the change is still unknown.

Furthermore, congressional inaction with budgetary concerns will create further future questions.

Change and concerns for the future create stress. The change in compensation formulas and new EMRs may create longer hours which may add to physician burnout. While healthcare reform may eventually be good for our patients and for the practicing physician, in the short run it is causing health issues for the physician.

As physicians we need to be aware of our environment and the personal risk for burnout. Fatigue and personal factors need to be realistically acknowledged so that they can be countered with behavior to improve health. Just as we counsel our patients.

We can control many of the stress-causing issues. Usually these are not related to complicated patient medical problems, but rather result from paperwork or administrative disagreements. We often feel there is not enough time to exercise or get enough sleep.

## **Fiscal Cliff Law Impacts Medicare Participation Options**

The 2013 Annual Participation Enrollment Program allowed eligible physicians, practitioners, and suppliers an opportunity to change their participation status by December 31, 2012. Given the enactment of the "American Taxpayer Relief Act of 2012 (H.R. 8), CMS announced that it will extend the 2013 Annual Participation Enrollment Program through February 15. Therefore, participation elections and withdrawals must be post-marked on or before this date. The effective date for any participation status changes elected by providers during the extension remains January 1, 2013.

#### "Fiscal Cliff" and Medicare Cuts Temporarily Averted

The Senate and House approved the "American Taxpayer Relief Act of 2012" (H.R. 8) by votes of 89-8 and 257-167, respectively, on January 1. The President signed the Act into law on January 2.

The Act extends the 2012 Medicare physician payment rates through December 31. As a result, the 26.5 percent reduction scheduled for January 1 was averted. H.R. 8 provides for a zero percent update for claims with dates of service on or after January 1 through December 31. According to the Centers for Medicare and Medicaid Services (CMS), Medicare claims administration contractors will be posting the Medicare physician fee schedule payment rates on their websites no later than January 23. The 2013 conversion factor is \$34.0230.

The non-partisan Congressional Budget Office (CBO) estimates that the one-year freeze will cost approximately \$25 billion over ten years. To partially offset this cost, Congress reduced Medicare and Medicaid funding to hospitals and other providers by approximately \$10.5 billion. These savings are accomplished through documentation and coding adjustments under Medicare's inpatient prospective payment system. In addition, changes were made to Medicare's end-stage renal disease bundled payment system to save approximately \$4.9 billion over 10 years. While scored as budget neutral, H.R. 8 also repealed the Community Living Assistance Services and Supports (CLASS) Act, which was created under the Patient Protection and Affordable Care Act (PPACA, Pub. Law 111-152). H.R. 8 did not repeal the Medicaid primary care payment increase provided for in the PPACA. It is, however, likely to be part of future cost-cutting discussions.

H.R. 8 delays across-the-board cuts to federal spending, referred to as sequestration, through March 1. Under current law, physicians will be limited to a two percent reduction in reimbursement under Medicare if sequestration is allowed to take effect. It is certain that additional reductions impacting physicians and their patients will be part of the discussions to address the current federal debt ceiling and sequestration. The ACOI will continue to monitor congressional negotiations that would impact access to care.

#### **House Rules Address IPAB**

Following the convening of the 113th Congress, the House adopted the rules (H.Res. 5) under which it will operate for the next two years. Included in the rules package is a provision that addresses the Independent Payment Advisory Board (IPAB) established under the PPACA. IPAB is a 15 member panel created to come up with ways to restrict Medicare spending growth if it reaches a certain target. Its recommendations would automatically become law without prescribed congressional intervention.

H.Res. 5 as adopted eliminates PPACA's requirement that a replacement bill for the IPAB save equal amounts of Medicare money. In addition, it undoes the limitations for floor consideration provided for in the PPACA. To date, no members of the IPAB have been nominated or confirmed.

#### **ACOI Responds to Newtown, Connecticut Tragedy**

In response to the tragic events in Newtown, Connecticut and elsewhere, the ACOI has joined with a number of other physician organizations in recognizing the devastating consequences of gun violence and called on President Obama and Congress to act.

The increased firepower of assault weapons, semi-automatic firearms, high-capacity magazines, and high velocity ammunition heightens the risk of multiple gunshot wounds and severe penetrating trauma that results in more critical injuries and death. To this end, the organizations called on Congress to renew and strengthen the assault weapons ban, including banning high-capacity magazines. In addition, the letter states that physicians

should be able to have frank discussions with their patients and parents of patients about firearm safety issues and risks to help them safeguard their families from accidents. Finally, the letter supports increased funding for research in violence prevention and gun-related injuries and deaths.

## CMS Program Identified and Prevented \$115 Million in Fraud

CMS announced that the newly-operational Fraud Prevention System helped stop, prevent, or identify roughly \$115 million in fraudulent payment during its first year of operation. According to CMS, the system helped identify 536 leads that have lead to 511 ongoing investigations. The system uses predictive modeling and data analytics to review all Medicare fee-for-service claims for indications of fraud.

## Washington Tidbits: Different Times, Different Divisive Issues, Common Resolve....

The 113th Congress has been sworn in and party lines have been drawn. The electoral votes have been tallied and President Obama will be sworn in for a second term on January 20. Awaiting Congress and the President are issues over which there are deep divisions and no easy answers. The manner in which these matters are handled will impact generations to come and shape the direction of our Nation.

While at times it appears that Congress is intractably mired in its own inaction and insurmountable conflicts, perhaps there is hope. With a looming Civil War and some of the Nation's darkest days on the horizon, President Abraham Lincoln delivered his first inauguration speech on March 4, 1861. In concluding his comments he said, "I am loath to close. We are not enemies, but friends. We must not be enemies. Though passion may have strained, it must not break our bonds of affection. The mystic chords of memory, stretching from every battlefield, and patriot grave, to every living heart and hearthstone, all over this broad land, will vet swell the course of the Union. when again touched, as surely they will be, by the better angels of our nature." With the 2012 elections in the books, it is now time to work for the common good of the Nation and its people

### Congress Provides Tax Break for IRA Distributions

A provision of the "fiscal cliff" legislation that President Obama signed into law (American Tax Relief Act of 2012) on January 2, 2013 may be of interest to College members over the age of 70. It has the potential to benefit both members and the ACOI.

Specifically, those with an individual retirement account (IRA) can make a charitable deduction to ACOI through an IRA charitable distribution. This is important for those who must take mandatory distributions from their IRAs. The advantage to you is that as an individual you may exclude the amount of the distribution from your gross income. This provision is time-limited and distributions must be made before January 31, 2013, for the 2012 tax year, or December 31, 2013 for the current year.

The law has a special provision for making a 2012 tax-free charitable gift to ACOI from your IRA under certain circumstances. The term, "qualified charitable distribution," is used in the law to describe a charitable rollover. It is money that individuals who are 70 ½ years or older may direct from their IRA accounts as gifts to charitable organizations. The underlying purpose of the law is to alleviate tax burdens for older Americans. The extension allows individuals who received an IRA distribution in December, 2012 to elect to count that distribution (or a portion thereof) as a 2012 charitable rollover if the amount in cash is transferred to a charity by January 31, 2013.
