While ACOI's motto has long been "In service to all members, all members in service," I see the core of that service to be our efforts toward member education. We educate via traditional CME, by setting residency and fellowship standards and through leadership and advocacy. I think it is fair to say that the impact of our efforts to provide high-quality education has been profound.

We are connecting with more people now than ever before and we continue to grow. Our Council on Education and Evaluation supervises 113 internal medicine residency programs and 121 subspecialty fellowship programs. There are more than 1700 trainees in those programs. Our CME events continue to grow each year with nearly 2000 internists participating in our four major events in 2013.

**Rick A. Greco, DO, FACOI** was inaugurated as the new President of the ACOI at the Annual Meeting of Members on Sunday, October 13, in Indian Wells, California. The Member Meeting was the concluding event of the 2013 Annual Convention and Scientific Sessions. Dr. Greco Is a hospitalist in Wheeling, West Virginia. He has served on the Board of Directors since 2004. More than 1200 members attended the Convention.

During the business meeting, the members elected a slate of officers proposed by the Nominating Committee. **Judith A. Lightfoot, DO, FACOI**, an infectious diseases specialist in Stratford, New Jersey was elected President-elect. **John B. Bulger, DO, MBA**, a general internist in Danville, Pennsylvania was elected to the office of Secretary-Treasurer. **Martin C. Burke, DO, FACOI, Scott L. Girard, DO, FACOI,** and **Samuel K. Snyder, DO, FACOI** all were elected to three-year terms on the Board of Directors. **Robert L. DiGiovanni, DO, FACOI** was elected to complete the one year remaining in Dr. Bulger's Board term.

The members also approved sweeping changes to the College's bylaws. Most of the changes were editorial. Substantive changes were approved in the emeritus and retired member categories of the bylaws. The previous requirements for Emeritus status were 25 years of Active membership and complete retirement from employment. The change would permit Emeritus status for all members with 35 years of Active membership, regardless of employment status. Retired member status would be made available to any member who is fully retired from practice. The requirement that the member be age 65 and older would be eliminated. Taken together, the two changes above would reward those long-time members who choose to continue to work, while providing the flexibility to provide retired status for younger physicians who decide to leave practice.

# **Avoiding Payment Reductions**

Physicians who provide Medicare Part B professional services should be aware of a negative 1.5 percent payment adjustment under the Physician Quality Reporting System (PQRS) for individual eligible professionals (EPs) who do not submit data on PQRS quality measures to CMS in 2013. The payment reduction will be implemented in calendar year 2015. EPs can submit data through the traditional PQRS methods (claims, registry and EHR) to avoid the 2015 payment adjustment and potentially earn a 2013 incentive payment of 0.5 percent. # **House and Senate Committees Review ACA Rollout**

House and Senate committees with jurisdiction have conducted their first series of hearings examining the implementation of the Patient Protection and Affordable Care Act's (ACA) health insurance exchanges. Testimony was provided by four representatives of contractors responsible for the design and operation of the federally-facilitated marketplace website. In addition, Secretary of Health and Human Services Kathleen Sebelius and Centers for Medicare and Medicaid Services (CMS) Administrator Marilyn Tavenner testified before the committees. Following the hearings, additional information has been requested from federal officials. Additional congressional action is expected. The ACOI will continue to closely monitor this and other matters related to the implementation of the ACA.

# New CBO Report Updates Cost to Reform Physician Reimbursement Rate

The non-partisan Congressional Budget Office (CBO) recently released a revised cost estimate to reform physician reimbursement under the Medicare program. Specifically, the CBO estimates the reform mechanisms contained in the "Medicare Patient Access and Quality Improvement Act" (H.R. 2810), as approved by the House Committee on Energy and Commerce, would cost approximately \$175.5 billion over ten years. This estimate is up from the \$139 billion estimate released earlier this year.

According to the CBO, its earlier estimate reflected a repeal of the Medicare Sustainable Growth Rate and maintaining current payment levels. H.R. 2810 would repeal the SGR and provide a positive update of .5 percent from 2014 through 2018. Absent congressional intervention, physicians are facing an estimated reduction of 24.7 percent in January 2014. It is important to note that the revised cost estimate is still below last year's estimate of \$245 billion. The CBO cites a reduction in physician spending under the Medicare program for the reduced cost of a repeal. Still unresolved in this debate is how Congress will pay for the repeal and replacement of the SGR with a positive update. Current budget and debt ceiling negotiations will also complicate negotiations going forward. The ACOI will continue to monitor this situation closely.

# \$14.2 Billion Spent on Health Professional Training in 2012

According to a report released by the General Accounting Office (GAO), the federal government spent \$14.2 billion on 91 programs for postsecondary training or education for health professionals in fiscal year 2012. The programs were administered through the Department of Health and Human Services (HHS), Department of Veterans Affairs, Department of Defense and Department of Education. Graduate medical education accounted for 78 percent of the expenditures. Medicare payments to hospitals in the form of Direct Graduate Medical Education and Indirect Medical Education accounted for about 66 percent of total reported healthcare workforce training funding. # **HHS Releases Model Documents to Assist with HIPAA Compliance**

HHS released 16 model notices of privacy practices for healthcare providers and others to assist in meeting requirements under the Health Insurance Portability and Accountability Act (HIPAA). The notices are required to inform patients of a provider's privacy practices. According to an HHS release, "Many entities have asked for additional guidance on how to create a clear, accessible notice that their patients or plan members can understand." The new model notices are intended to meet this need and are provide in three options: notice in the form of a booklet; a layered notice that presents a summary on the first page, followed by detailed comment; and, a text only version. # CMS Face-to-Face Requirement for DME Postponed

The Centers for Medicare and Medicaid Services (CMS) announced that it again will postpone a requirement that medical providers have a face-to-face encounter with a Medicare beneficiary within six months of prescribing durable medical equipment. The requirement was established in the Patient Protection and Affordable Care Act (ACA). The new date for enforcement of the requirement will be announced in 2014. According to CMS, "CMS expects all durable medical equipment suppliers to have fully established such internal processes and have appropriate documentation of required encounters by a date that will be announced in calendar year 2014." # Census Bureau Releases Report Detailing Health Insurance Coverage

According to a report recently released by the US Census Bureau, the percentage of people without health insurance coverage declined in 2012. The report indicates that people without coverage declined to 15.4 percent, down from 15.7 percent in 2011. Further, the percentage of people with health insurance increased to 84.6 percent (263.2 million), up from 84.3 percent (260.2 million) during the same time period. # Washington Tidbits: Capital for a Day...

Several US cities served as our national capital during the infancy of our nation. After the government fled from Philadelphia, PA due to advancing British forces, Lancaster, PA became the seat of power for just one day. It served as the government's epicenter on September 27, 1777. Since most of Pennsylvania's state government was located in Lancaster at the time, the Continental Congress felt it necessary to create a separation and crossed the Susquehanna River to set up the government in York, PA. York served as the nation's capital until June 27, 1778 when it was moved back to Philadelphia. It was not until 1800 that Washington, DC became the permanent

toward taking on further leadership opportunities, I found this course to be invaluable."

The program, which began in January, introduced participants to new subject matter at three week intervals. During this interval, participants reviewed primary content and supplemental videos; read assigned materials from Harvard Business Review and other sources; created an online virtual learning community by sharing answers to case study exercises; and completed short quizzes designed to test and reinforce key concepts introduced in each unit. All coursework was completed while working remotely, using desktops, laptops or tablet computers at a time and location convenient for the participants.

One of the many highlights of the course was a serialized case study about the Bailey Clinic. The case follows a successful seven-physician general internal medicine practice in northern Michigan as it transforms from a traditional care model to a Patient Centered Medical Home utilizing an interdisciplinary, physician-led team to provide care for its 25,000 affiliated patients and families.

The exercise that accompanied each new chapter of the Clinic's journey asked participants to apply new knowledge and insights from the class to help clinic leadership resolve differences and move toward their goal. This approach also strengthened shared learning as classmates benefited from each other's posts and faculty commentary.

With an initial group of graduates benefiting from the knowledge and insights acquired by successfully completing this program in 2013, ACOI leaders and University of Texas at Dallas faculty are looking forward to welcoming the next group of participants when class begins in January 2014.

The 2014 Certificate Program in Healthcare Leadership and Management will build on the successful 2013 program. This innovative, asynchronous online education program was designed to provide ACOI members an opportunity to acquire the new knowledge and skills outlined in the Phoenix Physician concept paper published by ACOI thought leaders in 2012. (See box below.)

The course content is organized in three sections: 1.) Interpersonal and Communication Skills; 2.) Leading and Managing in an Interdependent World; and, 3.) Providing Value-based Care for Individuals and Groups. Throughout the certificate program, participants will explore areas of importance to help the practicing physician cope effectively with emerging healthcare delivery changes accelerated by the Affordable Care Act and private sector initiatives related to care delivery and reimbursement. According to Neil J. Belgiano, DO, FACOI, a general internist from Milford, MI, "I would recommend this to anyone interested in medicine and where it is going to be in the next five to ten years."

# **AOBIM Announces Hospital Medicine OCC Examination**

The AOBIM will be instituting Osteopathic Continuous Certification (OCC) in Hospital Medicine beginning in the Fall of 2014. This examination will be open to those internists certified in Internal Medicine who concentrate their practice in inpatient medicine. To be eligible, one must be certified in Internal Medicine by the AOBIM and meet other practice and CME requirements. Those passing the examination will relinquish their Internal Medicine certificate which will be replaced by a certification certificate in "Internal Medicine with Focused Practice in Hospital Medicine." Registration and application will open November 1, 2013. Complete information will be published on the AOBIM website in November, but can be obtained now by sending an email to admin@aobim.org. # AOBIM Announces Last Opportunity to Sit for Hospice and Palliative Medicine Examination

There will be one additional examination in 2014 in Hospice and Palliative Medicine available to those applying via the Clinical Practice Pathway. The amendments to the bylaws must be approved by the AOA Board of Trustees before becoming effective. This action is expected in March, 2014.

The business meeting included reports from the Executive Director and Finance Committee. For the fiscal year ending June 30, 2013, the ACOI experienced a net profit of \$82,336. Finance Committee Chairman Jack D. Bragg, DO reported that revenues were \$3.14 million and expenses were \$3.05 million. He noted that total assets of the College grew to \$2.7 million.

A raffle on behalf of ACOI's fundraising activities also took place during the business meeting. More than a dozen prizes were awarded, including half of the proceeds of a 50-50 raffle totaling approximately \$3500, which was won by **David Greathouse, DO** of Macomb, Illinois.
